I am not an employee, servant, or agent of LaCrosse Fairgrounds Speedway. I hereby agree to abide by all rules and regulations of LaCrosse Fairgrounds Speedway.

PRINT/PHOTOS – LaCrosse Fairgrounds Speedway media accreditation terms and conditions include (but are not limited to) the provision that any stories produced, and/or still photographs taken at each event will be used for media purposed only **AND NOT FOR COMMERCIAL USE. MARY SCHILL – FORTE DESIGN has an exclusive right to ALL PHOTO SALES** – online or at the track – from LaCrosse Fairgrounds Speedway and such as **MARY SCHILL – FORTE DESIGN is the Official Speedway Photographer(s). Anyone else caught selling photos or posing as an official speedway photographer and/or simply wearing a shirt that indicates “official”, thus creating the perception that he/she is in some way an official of any kind, will have their credentials denied or immediately revoked for the remainder of the season, and may be asked to leave the speedway premises.**

The undersigned understands that he/she and beneficiaries, executors, and assigns will be entitles to the benefits of insurance coverage provided by LaCrosse Fairgrounds Speedway for accidental injuries or death which occur as a result of external, violent, and visible means sustained during LaCrosse Fairgrounds Speedway events. The coverage of said policy shall constitute the limit of liability of LaCrosse Fairgrounds Speedway for such injuries occurring to the undersigned in any LaCrosse Fairgrounds Speedway event provided proper notification is filed with LaCrosse Fairgrounds Speedway management prior to that person leaving speedway property. **The undersigned fully understands that a race car exposes him/her to risks that can lead to serious bodily injury or death. The undersigned voluntarily assumes these risks.**
